Media enquiry:

I have been contacted by a welfare academic who has concerns about a significant number of errors in Deloitte's report for DEWR on the targeted compliance framework.

The report refers to works by Lisa Burton Crawford:

- Lisa Burton Crawford, The Rule of Law and Administrative Justice in the Welfare State: A Study of Centrelink (Federation Press, 2021) 47–9. (references on pages 52, 58, 73, 78 and 88)
- Lisa Burton Crawford, The Rule of Law and Administrative Discretion (Federation Press, 2021) 112–115. (on page 53)

The author has confirmed that neither of these works exist, although she has published blog posts with similar titles and did write The Rule of Law and the Australian Constitution, published in 2017.

There is also a reference to Carolyn Adams, 'Choice, Responsibility and the Regulation of Behaviour: Lessons from the Social Security System' (2012) 35(2) University of New South Wales Law Journal 417, 426–8. This work also does not appear to exist.

Deloitte report's cited article: Terry Carney, 'Automating Compliance and Administrative Justice in Australia's Welfare State' (2024) 31(1) Journal of Social Security Law 32, 32–48.

When the article's real title is: Terry Carney, 'Automation and conditionality: towards "virtual" social security?' Journal of Social Security Law (2024) 31(1). Deloitte used Carney;'s work to justify 'defining core architectural principles to ensure modularity, etc'. The article actually makes arguments AGAINST 'excessive restricted conditionality' (see page 33).

Targeted Compliance Framework – Statement of Assurance and Final Report

I am writing in relation to the errors identified in the Independent Assurance Review of the Targeted Compliance Framework (TCF) – Statement of Assurance and Final Report. The Department of Employment and Workplace Relations (the department) commissioned Deloitte to undertake the Review in December 2024, seeking independent advice on whether the system underpinning the TCF was operating as intended. In commissioning this work the department expected the highest level of quality assurance and expert advice underpinned by clear evidence.

As we have consistently raised throughout the last few weeks, and reinforced at our meeting on Friday 5 September 2025, the errors identified in citations and references after the Final Report was submitted risk undermining the substance and credibility of the analysis and recommendations. They also create reputational risk for both the department and Deloitte.

I appreciate your continued assurance that Deloitte stands by the recommendations, methodology and findings of the review. However, I seek your confirmation to the agreed next steps in response to the issues identified as follows:

Deloitte's process of assurance addressing corrections in the Statement and Report

You have undertaken to thoroughly review the Statement of Assurance and the Final Report, and provide the department with updated documents in the coming days. I also request Deloitte provides a statement outlining the corrections, the process undertaken to verify citations and references, and your firm's commitment to the Review that can be published alongside the updated report.

2. Updated notification to the Department of Finance

On 2 September 2025 you wrote to the Department of Finance addressing the issues raised by media reports on the accuracy of references in the Final Report. In this letter you refer to Deloitte's use of generative AI tools to support the efficiency and quality of the Review. As you state, after first assessing the business case, the department agreed to the use of specific AI tools to support the analysis of IT code as part of the Review. However, your letter also refers to the use of generative AI in two publishing-related tasks: summarising a legal case for formatting purposes, and completing and formatting citations. You confirm these tools likely contributed to the errors identified in the reports.

Your letter states: DEWR was advised of the nature and cause of the errors, together with the media enquiry and Deloitte's proposed response.

While Deloitte staff immediately apologised to the department for the errors, and confirmed they were limited to poorly transcribed citations and references, at <u>no point</u> was the department advised that the cause of the errors was attributed to the use of generative AI tools.

I ask that you correct this point with the Department of Finance in writing, and copy me on this and any further correspondence with the Department of Finance regarding this contract.

3. Repayment of the final instalment under the contract

The final payment under the contract was based on the delivery of a Final Report that met professional quality standards. Given the issues identified with the final product, and your acknowledgement that internal Deloitte policy regarding communicating the use of AI to the client was not followed, I ask that the final instalment totalling \$97,587.11(incl. GST) be repaid to the department immediately.

I look forward to your urgent response to the matters raised.
