In the interest of an evidence-based understanding of issues pertaining to the content of enterprise agreements and wider access by the public to Workplace Agreements Database (WAD) data from December 2017, the Department will make the data prepared for the customised requests available to other parties on request. The original requestor's information or the purpose of the request will not be published.

Users must provide the Department with any material containing information drawn from the data that the user intends to make publicly available, prior to making that material publicly available.

Please note that for reference purposes, the user must attribute the Department as the source of the data, but must not present the data in such a way as to suggest that the Department endorses the material in which the data appears. The data source is to be referred to as "Attorney-General's Department, Workplace Agreements Database".

Privacy Notice
