VET Student Loans 2023 course list and loan caps

The <u>VET Student Loans (Courses and Loan Caps)</u> Amendment Determination (No.4) 2022 (Amendment <u>Determination</u>) came into effect on 1 January 2023.

The <u>VET Student Loans (Courses and Loan Caps) Determination 2016</u> (the Determination) lists the courses approved for VET Student Loans (VSL), including the loan caps for each course. The <u>VET Student Loans</u> <u>Course Caps Indexed Amounts (for providers)</u> lists the indexed VSL loan cap amounts for 2023. These amounts have also been listed in Table 1 below.

Schedules 1 and 2

Additions

There have been 7 courses added to Schedule 1 of the Determination as they now meet the VSL eligibility criteria of being current and either:

- On at least two state and/or territory subsidy/skills lists; or
- A STEM related course; or
- Required for occupational licensing.

There have been 31 courses added to Schedule 1; and 1 course has been added to Schedule 2 of the Determination as they are replacing VSL approved courses that are now non-current. Under a VSL provider's Conditions of Approval (Superseded and replacement courses), providers are automatically approved to offer replacement versions of superseded or non-current courses, subject to the replacement course being on the provider's scope of registration.

VSL providers will no longer need to notify the Department to request activation of new superseding courses in HITS when they are added to their scope on <u>training.gov.au</u>. If providers have VSL approval for a course that is superseded, once the superseding course is added to their scope on <u>training.gov.au</u> the course will automatically be activated in HITS. This should occur within 48 hours.

Loan cap band changes

The loan cap band for 15 Schedule 1 courses has been increased, to ensure the loan cap is sufficient for the majority of full fee-paying students.

The increased loan cap applies for the courses listed below, to both new and continuing students in respect of units with census dates from the date the Amendment Determination comes into effect. However, course or unit prices **cannot** be increased for current student cohorts.

Where course or unit fees have been published and therefore advised to the student, they cannot be increased (unless approved following the processes outlined in the <u>VET Student Loans Manual for</u> <u>Providers</u>). However, students may wish to access increased loan amounts to cover upcoming gap or up-front amounts (as per existing published amounts). Providers are reminded of the provisions relating to variation of tuition fees – which do **not** allow retrospective increases in tuition fees unless in circumstances approved on application to the Department's Secretary's delegate (refer sections 4.8.13 and 4.8.14 of the Manual).

If there is a change to the VSL amount the student wishes to access (where an increased loan cap applies), a new 'VET Student Loan Statement of Covered Fees' and 'VET Student Loan Fee Notice' needs to be issued to the student. These documents assist students to understand the component of their fees covered by the VSL, and the component that needs to be paid up-front.

If providers have existing approval to offer VSL for the courses that have changed loan cap bands, no action in relation to course approvals is required. Providers seeking to increase their 2022 Provider Fee Limit to accommodate these changes, should contact the Department by emailing <u>vetstudentloans@dewr.gov.au</u>.
