

## Bargaining in 2026

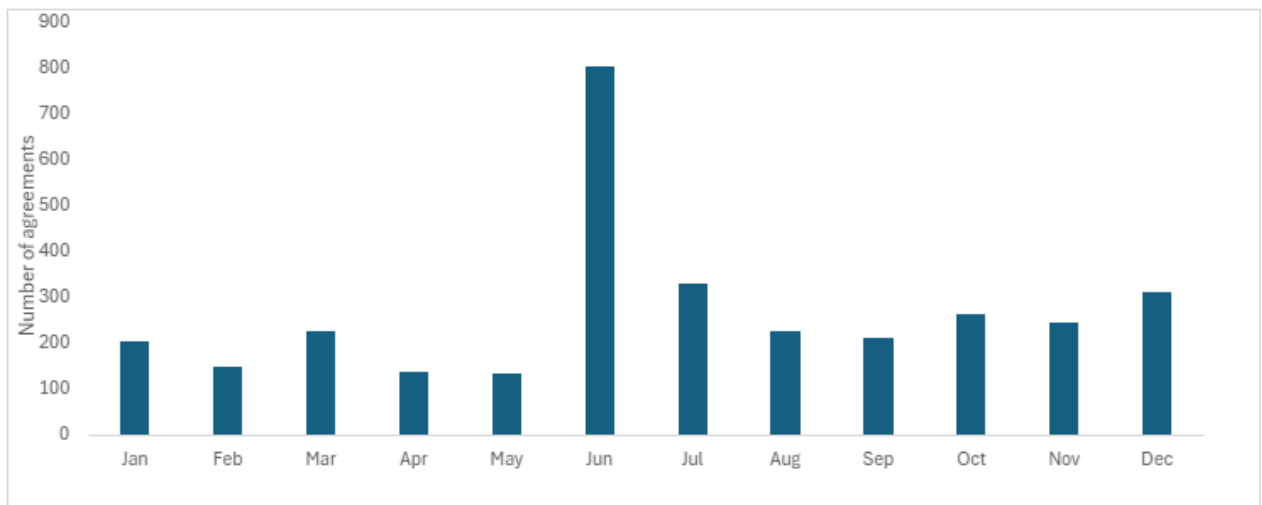
### Key Issues

This submission provides an overview of expected enterprise bargaining activity in the Federal workplace relations system for 2026, focusing on the key areas of possible industrial disputation.

#### *Expiring agreements*

In 2026, 3,232 enterprise agreements covering 818,900 employees will nominally expire, with a significant number nominally expiring in June 2026, aligning with the end of the financial year (see Figure 1).

**Figure 1 – agreements expiring by month in 2026**

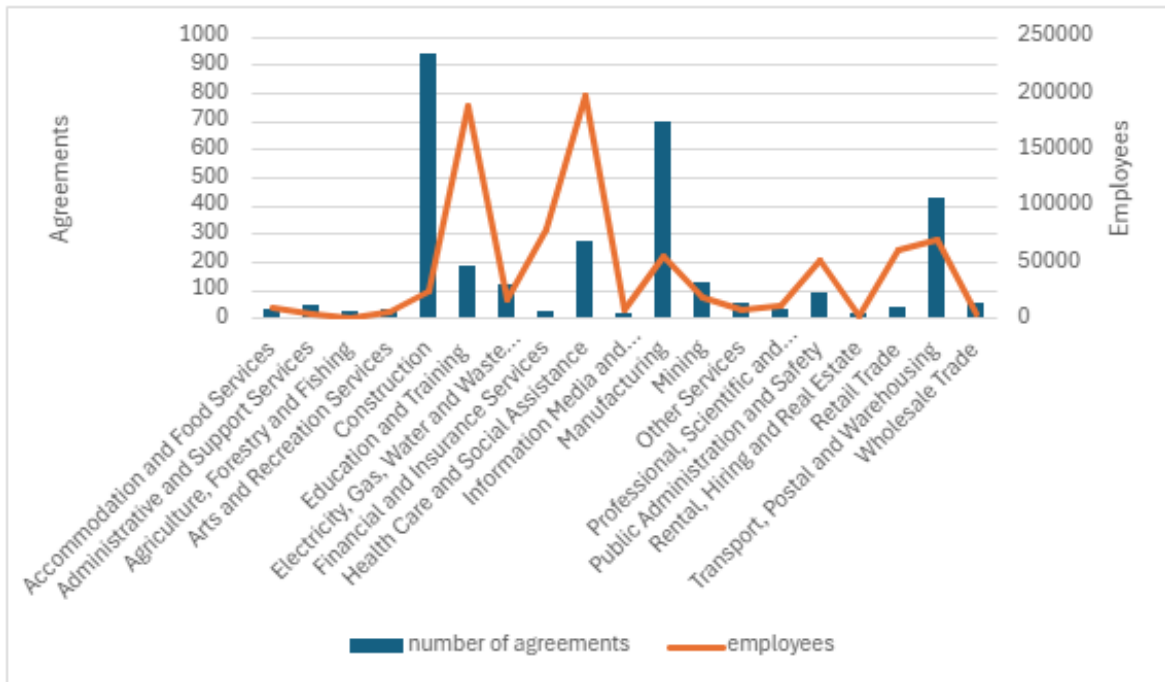


The sectors with the most agreements nominally expiring in 2026 (see Figure 2) are Construction (939), Manufacturing (696), Transport, Postal and Warehousing (426) and Health Care and Social Assistance (275). A considerable proportion of nominally expiring agreements in the Construction and Manufacturing sectors cover 30 or fewer employees (80% and ~50% respectively).

Sectors with the highest number of employees covered by agreements nominally expiring in 2026 are Health Care and Social Assistance (199,057 employees), Education and Training (188,395 employees), Financial and Insurance Services (80,002), Transport, Postal and Warehousing (70,983 employees), Manufacturing (55,353 employees) and Public Administration and Safety (50,960 employees).

### Industrial disputation

The risk of agreement renegotiations involving industrial action will vary from agreement to agreement and the likelihood of action will depend on a range of factors. Protected industrial action is generally expected to increase as bargaining activity increases. However, consistent with long term trends, we expect that the majority of enterprise agreement negotiations in 2026 will be finalised without recourse to protected industrial action.

Overall levels of industrial action in Australia remain historically low, noting Australian Bureau of Statistics (ABS) data which found that in the September 2025 quarter there were:

- **4.2 working days lost per thousand employees** due to industrial disputation. This compares to 2.1 working days lost per thousand employees in the June quarter 2025, and 3.4 days lost in the September quarter 2024.
- **55,100 working days lost** due to industrial disputation in the September quarter 2025, compared to 28,500 in the June quarter 2025.
- **87 industrial disputes** in the September quarter 2025, compared to 44 in the June quarter 2025.

It is important to note that the ABS data on days lost due to industrial disputation includes all protected industrial action, including action taken under state workplace relations systems. Industrial action involving state government employers with large numbers of employees can make a significant impact on this data. For example, in the September quarter 2025, over 50,000 Queensland public school teachers were reported as participating in a 24-hour stoppage.

### Potential industrial disputes in 2026

While it is difficult to predict precisely where and when industrial disputes may occur in 2026, our broad predictions and analysis are outlined below. Considering cost of living pressures, we expect to see unions continuing to push for wage increases in enterprise agreements that exceed the rate of inflation.

The department's Registered Organisations and Industrial Action Policy Team engages with employers and unions and monitors the progress of private industry enterprise bargaining within the federal workplace relations system. We will continue to provide weekly updates summarising current enterprise bargaining disputes as well as ongoing updates in relation to any high-profile matters.

### Manufacturing

The Manufacturing sector regularly experiences higher levels of protected industrial action compared to other industries. This is likely to continue to be the case in 2026 with almost 700 agreements nominally expiring.

### Transport, Postal and Warehousing

The department expects that there will be very significant protected industrial action in the Transport, Postal and Warehousing industry in 2026.

The Transport Workers Union (TWU) has announced that in 2026 it will be running a campaign, 'Our roads, our skies, our future' to set better sector standards and align enterprise agreements.

In its campaign material, the union notes that:

- For the first time in history, transport workers have aligned 200+ Enterprise Agreements across aviation and road transport to expire together in 2026.
- With the combined strength of 60,000 transport workers across the roads and skies, this is our chance to fight for better pay and conditions to future-proof the whole industry.

Data sourced from the department's Workplace Agreement Database suggests that the numbers claimed by the union are broadly correct.

## Overall Story

There are 500 enterprise agreements (EAs) involving transport expiring in 2026 covering a total of 78,521 employees. These agreements represent 38 different combinations of states. The 21 National agreements cover the most employees, with 16524 employees represented. NSW is a close second with 14482 employees covered.

- Of all the EAs, 137 agreements will expire on June 30 covering 33584 employees.

Of the 500 transport EAs, there are 218 enterprise agreements to which the Transport Workers Union (TWU) is a party. The TWU enterprise agreements cover 49,847 employees. These agreements represent 23 different combinations of states. Similar to the all the transport agreements, the 8 national agreements cover the most employees with 14,119 employees represented. NSW is a close second, with 8,665 employees covered.

- For the TWU EAs, 87 agreements will expire on June 30.
