

# Fact Sheet: Overview of Eligibility applications in ADMS

### ADMS Home Screen

To begin your application for LAFHA eligibility application, you will first need to <u>log into</u> <u>ADMS</u>.

After you have logged into ADMS, you will see the ADMS home page. Click the 'Review my LAFHA eligibility application' button in the Actions section to begin your application.



## Apprentice Eligibility application

Clicking on the 'Review my LAFHA eligibility application' button will open the eligibility application. When completing your application, you will need to add information and evidence to support your application before submitting.

#### Document evidence required

The Document evidence required section provides details on appropriate document evidence for an apprentice to support their application.

Document evidence required
Note     You are required to upload documents as evidence to support your application.
The evidence required must include: <ul> <li>a statutory declaration from the parent or legal guardian stating:</li> </ul>
<ul> <li>their residential address; and</li> <li>that the Australian Apprentice resided at that address immediately prior to moving to take up the Australian Apprenticeship; and</li> </ul>
<ul> <li>this is the first time the Australian Apprentice has moved away from home; and</li> <li>the date the Australian Apprentice moved from the parental or legal guardian home.</li> </ul>
<ul> <li>proof of their current residential address which may be in the form of:</li> </ul>
a rental receipt or
<ul> <li>any local government or statutory authority document; or</li> </ul>
<ul> <li>a statutory declaration from the owner of the residential premises; or</li> </ul>
<ul> <li>a document from the real estate agent from whom the Australian Apprentice is renting the property.</li> </ul>

#### Upload document evidence

Evidence to confirm your identity and residency status is required to support your loan application. Documents can be uploaded with the following format: ".jpeg", ".jpg", ".bmp", ".png", ".tiff", ".xls", ".xlsx", ".pdf", ".doc", ".docx", ".ppt", ".pptx".
