

PALM scheme worker deaths

- The death of any Pacific Australia Labour Mobility (PALM) scheme worker is a tragedy, and the department extends its sympathies to the families, friends, employers and communities.
- The Australian Government takes the welfare and wellbeing of PALM scheme workers seriously and continues to work with PALM scheme employers to promote safety.
- necessarily related to their employment or engagement in the scheme.
- There have been no PALM worker deaths which have been determined to be the result of a workplace fatality in 2023-24 or 2024-25.
- PALM scheme worker deaths are recorded only for those on-shore in Australia at the time of their death and do not include workers who are off-shore at the time of their death, or workers disengaged from the scheme.
- Figures for the number of PALM scheme worker deaths are unrounded.

Notes:

- Medical: includes disease or illness (chronic, underlying and other) and infection.
- Road fatalities: one fatal road crash may result in multiple worker road deaths. In 2023-24, there was one fatal crash which resulted in the death of 4 PALM scheme workers.
- Under investigation: investigation of PALM scheme worker deaths is undertaken by relevant authorities, including police, coroners and work safety regulators as required. The department does not routinely receive updates on the status of police or coroner investigations. While the department does seek updates where these are available, there may be delays in information received. Similarly, privacy provisions may mean that the department is not privy to the details of the investigation.
- The 'Other' category includes a range of causes including, but not limited to, injuries and physical accidents (work and non-work related), assault, homicide, misadventure, suicide, and other external causes.

- 'Serious injuries occurring in the workplace' are Critical incidents, as defined in the PALM scheme deed and guidelines, which involved a serious or life-threatening injury to a PALM scheme worker and that injury occurred in the workplace.
